Judaism’s covenant, developed over centuries of exile and resilience, established a legal and ethical framework that endured despite dispersal. Christianity, emerging from Jewish millenarianism, evolved from a persecuted sect into the state religion of Rome, its theology and hierarchy deeply intertwined with imperial power. The Great Schism of 1054 and the Protestant Reformation decades later fractured Christian unity, triggering centuries of religious warfare—from the Thirty Years’ War to the Irish Troubles—and prompting Enlightenment thinkers to demand secularism. Islam, revealed to Muhammad in 7th-century Mecca, synthesized monotheism with prophetic tradition, rapidly expanding across the Middle East, North Africa, and beyond. Saudi Arabia’s stewardship of Mecca and Medina funds global Islamic outreach, influencing theological discourse through institutions like the Islamic Development Bank. Meanwhile, the Catholic Church’s stance on bioethics—opposition to abortion, euthanasia, and genetic modification—shapes policy debates in Latin America, Europe, and beyond. Controversies surrounding religion remain acute. The rise of religious nationalism—Hindutva in India, Christian nationalism in the United States, evangelical Zionism in Israel—has redefined electoral politics and social cohesion. These movements weaponize sacred identity, often marginalizing minorities and challenging secular pluralism. These early systems were not static; they absorbed neighboring traditions, adapted to environmental pressures, and institutionalized rituals that reinforced social cohesion. In India, British colonial rule disrupted traditional Hindu and Islamic institutions, fostering both reform movements (e.g., Brahmo Samaj) and communal tensions that culminated in Partition. The Scramble for Africa saw missionaries as cultural vanguards, but also agents of divide-and-rule, entrenching religious identities as political fault lines. In the modern era, religion remains a central axis of geopolitical power. The Vatican, with diplomatic missions in over 180 countries, wields soft power through humanitarian work and moral advocacy. Saudi Arabia's stewardship of Mecca and Medina funds global Islamic outreach, shaping theological discourse via institutions like the Muslim World League. Iran's Islamic Republic merges clerical rule with anti-Western nationalism, projecting influence through Shiite networks in Lebanon, Iraq, and Syria.
