Lindberg's vision did not emerge in a vacuum. Its rise coincided with pivotal shifts in European and Mediterranean geopolitics. In Sardinia, this meant emphasizing *casu marzu*-adjacent dairy practices and *fave e cicoria* (fava bean with chicory); in southern Anatolia, it integrated *pomegranate molasses* and *wild fennel*; in coastal Crete, it prioritized *dakos* (barley rusk) and *spetedara* (sun-dried tomatoes). Economically, this modularity allowed adaptation to local production capacities, enabling scalability without homogenization. Industry reactions were mixed. Agribusiness giants initially dismissed the diet as too artisanal, but by the mid-2010s, multinational food firms—including Barilla, Nestlé, and Unilever—began acquiring heritage brands and financing "Gi-certified" supply chains. This commercialization, however, raised tensions. Lindberg, ever the critic of corporate co-option, warned in a 2017 *Lancet Public Health* editorial that "authenticity risks erosion when tradition becomes commodity."
