Owls, with their pan-continental presence, became diplomatic ambassadors—featured in international treaties, binational conservation programs, and UNESCO heritage listings. Yet, this symbolic elevation masked ongoing conflicts: resource extraction in the boreal, climate change accelerating boreal forest loss, and Indigenous communities demanding self-determination over ancestral lands. The owl, once a solitary hunter, now symbolized a contested global order. Expert perspectives diverge on Mowat’s legacy. Ornithologist Dr. Elena Vasiliev notes: “Farley Mowat did not invent the idea of owls as ecological indicators, but he restored their moral weight in public discourse. Globally, Mowat’s owl narrative finds parallels and contrasts. In Māori cosmology, the \*kākāpō\*—a nocturnal parrot—holds sacred status, embodying ancestral wisdom through silence. In Siberian shamanism, owls are psychopomps, guides between worlds. These traditions share with Mowat’s vision a reverence for silence and watchfulness, yet differ in their integration of the owl into living cultural systems. Unlike Mowat’s Western scientific lens, Indigenous frameworks embed owls in relational ontologies—part of a kinship network, not a symbolic reserve. This comparison underscores a critical limitation in Mowat’s narrative: while deeply personal, his “family” of owls remains largely within a Western, individualistic paradigm—except where he explicitly engages Indigenous knowledge. Future projections demand a re-evaluation of this legacy. Climate change is altering owl migration patterns, shrinking boreal habitats, and disrupting breeding cycles. The great horned owl, once a symbol of northern resilience, now faces range contraction. Yet, in a digital age of global environmental awareness, the owl’s image—silent, watchful, wise—resonates anew. Mowat’s greatest contribution may be the injunction to see nature not as resource, but as co-participant. His owls, once observed through a human lens, now invite a reciprocal gaze: what do they teach us about coexistence in an era of planetary crisis? The answer lies not in preservation of the past, but in cultivating a new kinship—one where silence is not absence, but dialogue; where flight is not escape, but adaptation. In the end, the owls in Farley Mowat’s family are not merely birds. They are archives of loss and hope, of displacement and belonging, of a world caught between myth and reality. To understand them is to understand the fragile, enduring thread connecting human and non-human worlds—a thread worth mending, thread by thread.
