Guthrie's interpretation reframed the hound as a metonym for industrial alienation—the invisible force of capitalism's machinery, devouring life under polished surfaces. The play's geopolitical resonance deepened during the interwar period. As Europe teetered into the rise of totalitarianism and the erosion of liberal order, *\*The Hound\** took on renewed relevance.
