In the dimly lit interview room of a Geneva think tank, seated across from a seasoned investigative journalist, Jonathan Lee Riches unfolded not just a narrative—but a chronicle of transformation, ambition, and the shifting tectonics of global capital. His voice, measured and deliberate, carried the weight of over two decades embedded in the heart of financial journalism, where transparency collided with opacity, and borders blurred behind flows of data and dollars. But it was his 2010 exposé on offshore financial networks linked to emerging market elites—published in

collaboration with the International Consortium of Investigative Journalists (ICIJ)—that catapulted him into global prominence. The piece, part of a broader investigation into hidden ownership through shell companies, revealed how political figures, oligarchs, and corporate executives in Southeast Asia, Africa, and Latin America used tax havens to shield wealth and evade accountability. Riches's meticulous tracking of financial flows, enabled by leaked documents from Mossack Fonseca, exposed a parallel economy operating beyond democratic oversight—a shadow infrastructure fueling inequality and undermining governance. This work positioned Riches at the nexus of a transformative moment in investigative journalism: the convergence of data analytics, cross-border collaboration, and digital forensics. The Panama Papers, released in 2016, were not Riches's discovery but his deep contribution—his ability to contextualize vast datasets within socio-political frameworks gave the disclosures analytical heft. He didn't just name names; he mapped networks, revealed patterns, and demonstrated how personal wealth was woven into the fabric of state power and global finance. Today, Riches emphasizes data journalism: network analysis, machine learning-assisted document parsing, and real-time tracking of financial transactions across jurisdictions. His team, embedded in a hybrid newsroom spanning Hong Kong, Nairobi, and Berlin, merges traditional reporting with technical rigor. 'We no longer follow the money blindly,' he explained. 'We map it—layering ownership, timelines, geopolitical alignments—to reveal the architecture behind power.' This methodology proved pivotal in his 2022 investigation into sovereign wealth fund investments in European green energy projects. By cross-referencing public filings, LinkedIn networks, and satellite imagery of construction sites, Riches' team exposed discrepancies between stated environmental commitments and actual land acquisitions—revealing how state capital was being leveraged not just for returns, but for strategic influence in the transition to a low-carbon economy. Yet, with such influence comes risk. Riches recounted how his team faced coordinated cyber intrusions, disinformation campaigns,

and diplomatic pressure from states implicated in the investigations. In one instance, a hacker group attempted to breach their secure
