Driven by post-9/11 security paradigms and the commodification of behavioral data, the consortium framed its project as a neutral infrastructure for "predictive governance." In reality, it became a prototype for what scholars now term "orchestrated informality"—a system where transparency is selectively applied, accountability diffused, and power concentrated in unaccountable nodes.

Geopolitical and Economic Foundations
