Economically, level-one analysis underscores how domestic industrial structures, resource endowments, and technological capabilities condition strategic choices. Nations rich in energy resources, such as Saudi Arabia or Russia, exhibit foreign policies calibrated to secure control over hydrocarbon markets, often at the expense of broader multilateral cooperation. Similarly, China's Belt and Road Initiative cannot be fully understood without examining the domestic imperative to absorb surplus industrial capacity, stimulate economic growth, and project geopolitical influence through infrastructure—a strategy deeply tied to internal stability and elite consensus. Critically, level-one analysis confronts the risk of over-nationalism in interpretation. Yet dismissing domestic agency risks reducing states to mere reflexes of internal dynamics, ignoring their capacity for strategic innovation and adaptation. The nuanced challenge is recognizing that domestic actors operate within institutional frameworks that both enable and constrain action—bureaucratic cultures, legal limits, and electoral cycles all shape the policy space.

Expert perspectives diverge on the primacy of level one. Realists like Mearsheimer argue that systemic pressures ultimately dominate, with domestic politics serving as a secondary amplifier. In contrast, constructivists and institutionalists emphasize feedback loops between domestic norms and international expectations—how domestic identity shapes perception of national interest, which in turn influences systemic behavior. This dialectic underscores the three-level model's strength: it acknowledges both structural constraints and domestic agency as co-constitutive.

The post-Cold War era witnessed a reconfiguration of level-two dynamics. The unipolar moment under U.S. hegemony temporarily diminished systemic multipolarity, but the 21st century's return to multipolarity—marked by China's rise, India's ascent, and the reassertion of Russian power—has reinvigorated competition at this level. States now maneuver within a fragmented system where no single actor dominates, compelling nuanced diplomacy, coalition-building, and strategic ambiguity. Economic interdependence adds another layer to level-two analysis. The rise of global supply chains and financial integration has created new dependencies and vulnerabilities. For example, U.S.-China strategic competition extends beyond military posturing into technology rivalry—semiconductors, artificial intelligence, and critical minerals—where economic leverage is weaponized. This hybrid form of power projection blurs traditional state-centric boundaries, illustrating how systemic competition reshapes domestic industrial policy and national security doctrine. Regional institutions further complicate level-two dynamics. The European Union, despite its internal tensions, exemplifies how states pool sovereignty to amplify collective influence—a countervailing force to unilateralism. Conversely, ASEAN's consensus-driven model reveals the limits of regional integration amid divergent national interests. These institutional arrangements reflect strategic adaptations to systemic pressures, where states balance autonomy against collective security and economic gain. Controversies arise over the extent to which level-two analysis can account for non-state actors and transnational threats. Critics argue that traditional state-centric models underemphasize the growing influence of multinational corporations, terrorist networks, and cyber actors—forces that challenge state monopoly on coercion and governance. From a strategic standpoint, level-two analysis offers essential insights for policymakers. It reveals the necessity of strategic patience and coalition management in great-power competition. The U.S. pivot to Asia, for instance, required not only military rebalancing but also deepening economic partnerships with ASEAN and Japan—leveraging systemic alliances to counterbalance China's regional influence. Similarly, NATO's evolution in response to Russian aggression underscores how systemic threats compel institutional adaptation and burden-sharing among allies.

The long-term implication is that level-two dynamics will increasingly determine the stability of the international order. As power diffuses across state and non-state actors, the capacity to navigate complex interdependencies—through diplomacy, economic statecraft, and institutional innovation—will define strategic success.

Level Three: The International or Global System - Structure, Norms,

and the Architecture of Order

The dominance of U.S. financial markets is being contested by the renminbi's internationalization, the rise of digital currencies, and the fragmentation of trade blocs. The WTO's weakening dispute settlement mechanism reflects declining trust in multilateral governance, while regional agreements like the CPTPP and RCEP signal adaptive responses to systemic uncertainty. Security dynamics at level three reveal deep contradictions. While nuclear deterrence maintains strategic stability between great powers, the proliferation of conventional and asymmetric warfare—cyberattacks, hybrid operations, and private military companies—complicates traditional notions of sovereignty and conflict. The 2022 invasion of Ukraine starkly illustrated how systemic norms (territorial integrity, non-aggression) can be violated with limited global enforcement, exposing the limits of institutional authority. Conversely, a failure to manage tensions risks fragmentation into competing blocs, eroding shared rules and increasing conflict probability.

The implications for global governance are profound. The 21st-century system demands new forms of legitimacy, inclusivity, and responsiveness.
