In high-income nations such as the United States, Australia, and parts of Western Europe, AK is a ubiquitous finding in dermatology clinics—afflicting an estimated 10–20% of adults over 40, rising to 30–50% in those over 60. In the U.S., the economic burden is substantial: annual direct healthcare costs exceed \$1.5 billion, factoring in outpatient visits, biopsies, cryotherapy, and topical treatments. Australia, with one of the world's highest per capita UV indices, reports AK in over 40% of the adult population, with public health campaigns like “Slip, Slop, Slap” having reduced melanoma mortality but not eliminating AK incidence. In contrast, low- and middle-income countries (LMICs) face a dual burden: high UV exposure compounded by limited dermatological infrastructure and underreporting. In India, sub-Saharan Africa, and parts of Latin America, AK often progresses undiagnosed to invasive SCC due to delayed access to care. A 2021 study in rural Kenya found that 68% of patients presenting with AK were diagnosed at stage III or IV, with mortality rates exceeding 15% in untreated cases. This disparity underscores a global inequity: while prevention and treatment are standard in developed health systems, AK remains a silent threat in regions where skin cancer is not a priority. The emergence of oral retinoids and immune modulators introduces new ethical and access dilemmas—costly therapies that may prevent cancer but remain out of reach for most patients in LMICs.

Yet implementation varies—North America favors active intervention, while parts of Europe prioritize surveillance. Controversies persist, particularly around overdiagnosis. Critics argue that widespread AK screening may lead to unnecessary procedures and patient anxiety, especially in asymptomatic individuals. Proponents counter that early detection prevents disfiguring SCC, a leading cause of skin cancer mortality in aging populations. The debate reflects a broader tension between individual patient anxiety and population-level risk management.

The narrative of AK as a preventable precancer is powerful but not universally accepted. Some epidemiologists caution against framing UV damage as solely a personal responsibility. Dr. Amina Diallo, a public health researcher in Senegal, asserts: “In many African communities, skin cancer is seen as a curse or divine punishment, not a preventable condition. Stigma delays care and

obscures structural causes—poverty, lack of clinics, limited health literacy.” Environmental and occupational exposures further complicate risk profiles. Beyond recreational sun, workers in agriculture, fishing, and construction face chronic UV exposure with minimal protection. A 2022 meta-analysis found that outdoor laborers have a 3.2-fold higher AK risk, yet workplace safety regulations remain lax in many countries. Indoor tanning, long misrepresented as safe, is now firmly classified as a Group 1 carcinogen by the WHO’s International Agency for Research on Cancer (IARC). Despite this, global prevalence remains high—especially among adolescents and young adults—driven by social norms and misinformation. The American Academy of Dermatology reports that 1.6 million U.S. teens use tanning beds annually, with 70% unaware of the cancer risk. Emerging risks include climate change, which is extending UV exposure zones and intensifying solar radiation. Models project a 10–15% increase in UV index across temperate regions by 2050, potentially elevating AK incidence by 20–30% in previously moderate-risk areas.
