Economists at the London School of Economics noted that the incident exposed a systemic blind spot: even institutions deemed “too stable to fail” could collapse overnight when governance eroded. Though not a full collapse—SVB avoided immediate insolvency—the halt marked the first major tremor in a sector long celebrated for innovation and stability. By year's end, SVB's troubles were exacerbated by a deposit run, fueled by fears of systemic contagion. Though rescued temporarily by the Federal Reserve, the event exposed deep vulnerabilities in the bank's business model. SVB's core client base—tech startups and venture capital firms—had grown increasingly dependent on its specialized lending and deposit services. Yet its reliance on short-term liabilities to fund long-duration assets created a classic liquidity mismatch. As interest rates rose in 2017–2018, unrealized losses on bond holdings

ballooned, eroding capital buffers. When market sentiment shifted, depositors, wary of contagion risks, withdrew funds en masse. Economists at the Federal Reserve Bank of San Francisco highlighted SVB's role as a bellwether for "niche financial intermediation." The bank's failure—though contained—revealed how specialized institutions, even with strong reputations, could become systemic risks when governance failed to adapt. The event spurred regulatory scrutiny of fintech lenders and prompted calls for expanded stress testing and deposit insurance coverage for emerging business models. Globally, February 26, 2018, signaled a turning point: the era of unregulated fintech dominance was ending. Investors and policymakers now demanded transparency, resilience, and accountability—even in the most agile corners of finance.

Geopolitical Echoes: Authoritarian Repression and the State of Emergency
