The rise of “data trust frameworks” and decentralized identity systems reflects industry adaptation. Firms are increasingly adopting federated data models, where raw data remains localized but processed outputs are shared under strict governance. This mirrors a broader trend: data is no longer solely an asset to be owned, but a shared resource governed through layered consent and accountability.
