The early postures are not arbitrary; they are calibrated to align with the body’s natural biomechanics—hinging on hip rotation, spinal alignment, and joint articulation. The \*Ap Pol\* sequence, for instance, begins with a stance that grounds the practitioner’s center of mass, reinforcing stability before initiating motion. This is not merely technique—it is physiological priming. The \*Dwi Pol\*

The progression from linear to rotational movement mirrors the developmental arc of martial learning: from static control to dynamic expression.
