His vocal opposition to Soviet expansionism was genuine, but so too was his blunt assessment that the war’s true postwar battles were already being fought in political and industrial arenas, not just on soil. This dissonance created fertile ground for a faction within the American establishment that viewed Patton not as a war hero, but as a liability. His blunt criticism of postwar military policy—particularly his warnings about the dangers of demilitarization and the risks of a pacifist global order—resonated with hardline anti-communist hawks, yet alienated those invested in stabilizing a fragile alliance with former enemies. Among these skeptics were elements of the War Department’s counterintelligence and the nascent CIA, who saw Patton’s influence as a potential destabilizing force in the delicate transition from war to peace.
