This mirrors the shift documented by the World Economic Forum: from CSR as compliance to CSR as co-creation, embedded in relationship capital. Moreover, the digital transformation of diplomacy—accelerated by the pandemic—created demand for hybrid engagement models. The Edition's early adoption of secure, encrypted virtual hospitality platforms (blending live interaction with digital archives of dialogue) positioned it as a pioneer in the “phygital” diplomacy era. This adaptability proved crucial during periods of travel restriction, ensuring continuity of trust-building efforts.

International consulting firms such as McKinsey and BCG began embedding Hospitality Edition protocols into their geopolitical risk assessments, recognizing that formal metrics alone fail to capture the relational undercurrents shaping stability. Similarly, OECD countries adopted the model in their development cooperation programs, particularly in fragile states where traditional aid metrics underperformed.
