Its answers—precise, outcome-driven, and algorithmically responsive—are not merely educational tools; they are instruments of soft power, cognitive engineering, and contested meaning-making. The origins of the OSEC answer framework lie not in a vacuum but in the long arc of postcolonial educational reform. For decades, English curricula across former British colonies and global English hubs operated under standardized models—primarily British and American—designed in the mid-20th century for a world order that no longer exists.
