China's aggressive infrastructure development—roads, tunnels, and radar systems—challenges India's strategic depth. India's reliance on indigenous defense manufacturing (e.g., BrahMos missiles, Akash air defenses) is growing, yet supply chain bottlenecks and bureaucratic delays hinder rapid modernization. Former Intelligence Bureau chief Shiv Singh Aggarwal stresses institutional modernization: 'We need AI-driven threat modeling, predictive analytics, and real-time inter-agency coordination platforms. Without digital transformation, our security apparatus will remain a patchwork of legacy systems.' His advocacy for a centralized, agile National Security Council mirrors recommendations from the 2021 Select Committee. Bureaucratic inertia further hampers reform. Defense and security budgets, though increasing, prioritize hardware over human capital and innovation. The 2023 Defense Budget allocated 2.1% to R&D—far below global peers like the U.S. (3.5%) and China (2.5%)—stalling indigenous development of secure communication systems and AI-driven threat analysis. Moreover, legal frameworks struggle to match modern threats. The UAPA, despite amendments, enables preventive detention without trial, raising human rights concerns. The 2021 NIA Act expanded surveillance powers but failed to establish independent oversight, risking state overreach.
