These texts circulated primarily in monastic or courtly circles, often accompanied by commentaries that interpreted Ashtavakra’s words through the lens of contemporary Advaita thought. Scholars such as A.K. Raman

(1976) and later Subhash Kak (2000) have noted the Gita's linguistic features: a poetic yet accessible Sanskrit marked by paradox, metaphor, and dramatic dialogue.
