The project cut production costs by 40% while generating local employment and reducing landfilling of agricultural residues. These successes attracted policy attention: Indonesia and Thailand began integrating OCS technology into national green growth strategies, offering tax incentives and technical support. Critics argued that decentralization risked fragmentation and reduced quality control. Yet OCS addressed these concerns through radical transparency. The organic chemistry sector experienced a tectonic shift as OCS's decentralized model gained traction. Traditional manufacturers, initially resistant, were forced to adapt.
