Yet, the fall of Rome led to a fragmentation of knowledge. Medieval Europe reverted to timber framing and lime mortar, with stone cathedrals rising as both spiritual and communal symbols, their construction sustained by guilds and religious patronage. The Industrial Revolution catalyzed a tectonic shift in construction. The mass production of steel—from Henry Bessemer's converter in 1856—revolutionized structural possibilities, enabling skeletal frames that defied gravity. The Home Insurance Building in Chicago (1885), often cited as the first modern skyscraper, embodied this transformation: steel skeletons supporting masonry and later curtain walls of glass and steel. Trade wars, such as the U.S.-China tariffs on steel, ripple through global markets, altering project economics and incentives for domestic alternatives. Meanwhile, the war in Ukraine disrupted nickel and palladium supplies, critical for corrosion-resistant steel in infrastructure, forcing engineers to explore substitutes. These dynamics reveal construction as a frontline of global competition and vulnerability. Risk assessment in construction is multidimensional. Material failure—concrete spalling, steel fatigue—often results from compounded stressors: design flaws, poor quality control, environmental exposure. The 2018 Morandi Bridge collapse in Genoa, Italy, exposed systemic underinvestment in maintenance and outdated design assumptions, killing 43. Climate change intensifies these risks: rising temperatures degrade asphalt, increased rainfall accelerates concrete spalling, and sea-level rise threatens coastal foundations. Resilient design is no longer optional—it demands adaptive materials, dynamic modeling, and lifecycle cost analysis. Innovation is accelerating. Bio-based materials—mycelium composites, hempcrete, bamboo laminates—offer carbon-negative alternatives, though scalability and fire codes remain barriers. 3D printing with recycled concrete or geopolymers promises precision
