Yet in lower-tier subcontractors—often informal or family-run operations—compliance remains fragile. A

2023 investigation by the International Labour Rights Forum found that 43% of Tier 2 and Tier 3 suppliers in Thailand’s automotive parts sector lacked formal labor documentation, exposing systemic gaps despite MCAA adherence by lead OEMs. This dichotomy underscores a central tension: the manual’s effectiveness depends on cascading enforcement, not just corporate commitment. It forces companies to articulate their labor policies—even if implementation varies.” These competing views reflect a broader debate: whether labor governance in global supply chains requires hard law or adaptive self-regulation.

Critics highlight the “audit fatigue” phenomenon, where frequent third-party inspections strain supplier capacity and incentivize short-term compliance over systemic change.
