The impact of Praxis 5343 on the audiology industry has been transformative. Expert Perspectives: Competence, Credibility, and Cultural Relevance The reception among practicing audiologists is nuanced. Veterans of ASHA and ASHA-aligned systems express cautious optimism, citing improved clarity in competency expectations and enhanced international mobility.
