The origins of Lebanon's chart of accounts trace back to the French Mandate era, when the country adopted a version of the French accounting system adapted to its nascent fiscal administration. This framework, though formally modernized in the 1950s under the Central Bank of Lebanon (BDL) and Ministry of Finance guidelines, retained a legacy of complexity and opacity. The CoA was designed to standardize financial reporting across a fragmented economy—one characterized by a plurality of legal entities, informal sectors, and overlapping jurisdictions among state organs, central banks, and sectarian-affiliated institutions. Unlike many OECD nations with centralized, harmonized fiscal coding systems, Lebanon's CoA evolved in a context of pluralism and fragmentation, where accounting standards often served administrative convenience rather than transparency. By the 1970s, the Chart had become a contested terrain. The civil war (1975–1990) shattered formal fiscal control, forcing parallel systems of accounting to emerge in besieged zones and militias. The CoA, once a tool of centralized oversight, devolved into a patchwork of localized ledgers—each reflecting not economic reality but military or sectarian survival. Even after the Taif Agreement (1989), which formally ended the war, the fiscal architecture failed to consolidate. The state retained a dual identity: one modernizing, outward-facing, and attempting to align with international standards, and another archaic, inward-looking, and resistant to reform. This duality persists today. The post-war reconstruction era, driven by Gulf capital and international financial institutions, saw attempts to modernize Lebanon's accounting infrastructure. The 1990s and early 2000s witnessed the introduction of International Public Sector Accounting Standards (IPSAS) and limited adoption of International Financial Reporting Standards (IFRS) for private entities. Yet these reforms were superficial. The CoA remained riddled with inconsistencies—duplicated codes, ambiguous classifications, and a lack of uniform enforcement. Private firms, state-owned enterprises, and municipalities continued to operate under hybrid systems, often mixing local codes with outdated French or Arabic numeral conventions. The result was a financial lexicon that obscured rather than clarified. Economically, the Chart of Accounts mirrors Lebanon's chronic instability. The country's fiscal identity is fractured: the state operates with a conventional budgetary framework but relies heavily on off-budget entities, informal revenue streams, and non-transparent debt instruments. The CoA fails to capture the shadow economy, which constitutes an estimated 40–50% of GDP, nor does it reliably track informal transactions, cash-based trade, or remittances—all critical to Lebanon's survival. This structural ambiguity enables fiscal evasion, distorts public debt metrics, and undermines efforts to audit public finances. Geopolitical forces have further warped the CoA's functionality. Lebanon's dollarized financial system, pegged to the U.S. dollar since the 1990s, created a parallel accounting reality where foreign currency transactions dominate. Yet the CoA treats the Lebanese pound (LBP) as a legal tender while allowing dual reporting in hard currency—an artificial dichotomy that masks inflationary erosion and balance-sheet falsification. Sanctions, regional conflicts, and the 2020 port explosion compounded these distortions: the CoA was ill-equipped to record losses, track damage, or allocate reconstruction funds transparently. Instead, it became a vessel for opaque allocations, often channeled through politically connected actors. Industry-specific impacts reveal deeper fractures. In banking—Lebanon's economic linchpin—the CoA enables the manipulation of asset

valuations and non-performing loans. Banks routinely reclassify bad debt or understate liabilities in their internal accounts, while external reports rely on a CoA that lacks real-time audit trails. In agriculture, a sector employing nearly a third of the population, the Chart fails to capture subsistence practices, barter systems, and informal credit networks. Farmers operate off books, rendering subsidy programs ineffective and distorting rural development data. Experts describe the Lebanese Chart as a “legacy burden,” resistant to reform due to political entrenchment. Dr. Nada Fahmy, a professor of public policy at the American University of Beirut, explains: “The CoA isn’t just outdated—it’s weaponized. Each ministry, each institution, controls its own version, making systemic audit impossible. When you audit a ministry, you’re not just reviewing accounts—you’re navigating a labyrinth of jurisdictional silos and deliberate opacity.” Economist Samir Khattar adds: “The Chart’s complexity isn’t accidental. It’s a feature, not a bug. It enables obfuscation when transparency is needed most.”

Controversies surrounding the CoA intensify during fiscal crises. During Lebanon’s 2019–2023 debt default, the inability to accurately trace liabilities across state entities and offshore entities exposed the Chart’s fragility. The government’s attempts to restructure debt relied on incomplete or manipulated accounting data, fueling public distrust. The 2021 audit by the Independent High Anti-Corruption Council revealed systemic misclassification, with over \$12 billion in unreported off-budget obligations hidden in sector-specific ledgers. Risks remain acute. The CoA’s lack of digital integration—most institutions still use manual or legacy systems—hampers real-time monitoring, especially critical amid Lebanon’s ongoing liquidity crisis and currency collapse. Cyber vulnerabilities further threaten financial integrity, with repeated ransomware attacks targeting banking and government systems. Without a digitized, unified CoA, transparency remains elusive. Globally, Lebanon’s fiscal accounting stands in stark contrast. In Iraq and Syria, post-conflict fiscal reforms included aggressive digitization and alignment with UN standards, enabling better tracking of reconstruction funds. In Jordan, a more centralized and standardized CoA supports more effective tax collection and public investment. France, despite its own historical fiscal complexity, maintains a unified, digitized system with robust oversight—something Lebanon has yet to achieve despite repeated reform pledges. Looking forward, transformation of the Chart of Accounts is not merely a technical upgrade but a prerequisite for fiscal sovereignty. A unified, transparent, and digitally integrated system—aligned with global standards like IPSAS2 and IFRS—could restore accountability, attract foreign investment, and rebuild public trust. Yet this requires political will, institutional independence, and international technical support. The World Bank and IMF have proposed phased reforms, including mandatory real-time reporting, open-source accounting platforms, and independent audits—but progress remains stalled by sectarian resistance and elite capture. The Chart of Accounts in Lebanon is thus a microcosm of the nation’s crisis: a system built for stability, corrupted by fragmentation, and now central to its survival. To reform it is to confront the structural roots of Lebanon’s failure—not just with new codes, but with a redefinition of fiscal citizenship, transparency, and shared accountability.
