Yet, this transformation relied heavily on migrant labor—over 1.5 million workers from South Asia, the Philippines, and elsewhere. The kafala system, which tied workers' residency to employer sponsorship, enabled systemic exploitation: wages delayed, passports seized, conditions perilous. By 2017, the Gulf Crisis exposed Qatar's vulnerabilities, yet its ability to withstand blockade—bolstered by Iran's logistical corridor and Turkish military presence—demonstrated newfound

The blockade, though officially lifted in 2021, left scars. Qatar's response was strategic: deepen ties with Turkey, expand relations with Iran and Israel's neighbors, and leverage its energy leverage to secure diplomatic support. The World Cup became a stage for this repositioning. Saudi Arabia, Qatar's regional rival, had long sought to dominate Gulf diplomatic and economic spheres. This reinforced Qatar's image as a neutral mediator—a role amplified by its Al Jazeera network, which provided balanced coverage of Iran's regional position. Globally, the event challenged U.S. and European influence. While Western media focused on human rights, state-controlled outlets in Asia and Africa framed it as a triumph of developing-world modernization. China, investing heavily in Gulf infrastructure, viewed the event as a validation of its Belt and Road Initiative's global reach. Russia, under sanctions, saw Qatar as a rare diplomatic interlocutor—evidenced by high-level visits during the tournament. The World Cup thus became a microcosm of multipolarity. It reflected a world where traditional Western dominance is contested by rising actors—state-backed media, sovereign wealth funds, and digital diplomacy—reshaping global narratives. For Qatar, the event was not just about football; it was a diplomatic coup, a repositioning in a shifting geopolitical order.

Its coverage highlighted both the celebratory spirit and systemic challenges—interviews with workers, investigations into construction sites, and analysis of labor reforms. Yet, critics accused it of soft-pedaling repression, particularly regarding dissent. Conversely, outlets like BBC and The New York Times scrutinized Qatar's human rights record, publishing exposés on migrant deaths and union suppression. This duality revealed a deeper truth: in the digital age, mega-events are no longer controlled by a single narrative.
