But what unsettled her most was the narrative control—how official accounts blamed “irresponsible spending,” while the root causes—predatory lending, deregulation, offshore speculation—were buried beneath layers of bureaucratic obfuscation. “We were told a story,” she later recalled in a 2015 interview with **Harvard Review**, “that made sense, that placed blame where it deserved to fall, but never explained why the system kept breaking.” This early disillusionment fueled her academic trajectory. At the University of Michigan, she immersed herself in political economy, media studies, and critical theory. Her senior thesis, “Narrative as Infrastructure: How Belief Systems Are Built and Broken,” argued that collective belief is not organic but**

engineered—constructed through media, education, and ritual. She drew on the work of Benedict Anderson, whose **Imagined Communities described nationalism as a narrative construct, but extended it to digital realms. “Truth isn’t discovered,” she wrote. “It is curated.” Her thesis was not met with universal acclaim. Some faculty dismissed it as overly deterministic; others praised its prescience. But it marked the birth of her central thesis: belief is not a personal truth, but a managed architecture—one designed, maintained, and exploited. This insight would define her career. Even before founding Chronos, she was analyzing how media ecosystems could amplify certain narratives while silencing others, foreshadowing the disinformation battles that would dominate the 2010s.**

The Rise of Chronos: From Idea to Institution

In 2014, Annabelle co-founded **Chronos Investigations** with a small group of like-minded journalists, technologists, and former intelligence analysts. The name, drawn from the Greek personification of time, reflected their mission: to investigate not just events, but the temporal patterns of narrative manipulation. At a time when legacy media was shrinking and digital platforms were consolidating power, Chronos embodied a new model—nonprofit, independent, and relentlessly long-form. Their early work focused on mapping the rise of “synthetic influence”—the use of bots, deepfakes, and coordinated campaigns to sway public opinion. One of their first breakthroughs came in 2015, when they exposed a Russian-linked network that had infiltrated U.S. political discourse during the presidential election cycle. Using open-source data and network analysis, they traced the flow of disinformation from Telegram channels to mainstream news amplification, revealing how a relatively small group of accounts could simulate grassroots momentum. This report, **“The Puppeteers’ Playbook,”** caught the attention of watchdog groups and foreign policy experts. But it also drew ire. Annabelle faced coordinated smear campaigns online—trolled by both state-backed operatives and domestic partisans who resented her findings. Yet she persisted, building a team that combined investigative rigor with technical expertise. Annabelle’s research revealed how these campaigns exploited platform algorithms—designed to maximize engagement—turning outrage into viral currency. As she noted in **“The Hollow Man”**, “The platform is not neutral. It rewards the loudest, not the truest.” Globally, China’s United Front Work Department refined its model of “sharp power,” blending state media, social media manipulation, and cultural influence to shape foreign perceptions. Iran’s Islamic Revolutionary Guard Corps expanded its cyber operations, using fake accounts and deepfakes to destabilize regional rivals. Meanwhile, Western democracies, despite their professed commitment to free speech, often failed to counter these threats effectively—either paralyzed by internal divisions or constrained by legal and political caution. Economically, the business models underpinning digital platforms incentivized the very behaviors Annabelle sought to expose. Ad-driven revenue depended on user engagement, which in turn favored emotionally charged, polarizing content. Startups like BuzzFeed and Vice Media initially thrived on this logic, but as misinformation spread, so did scrutiny. By the late 2010s, public backlash and regulatory pressure forced a reckoning—yet few platforms fully abandoned their engagement-centric models. Annabelle’s analysis emphasized that disinformation was not merely a technical failure but a structural outcome. These experiences forced a reckoning within Chronos. The team developed advanced digital security protocols, including encrypted communication, secure data storage, and threat assessment frameworks. Yet the psychological toll persisted. Annabelle spoke candidly about insomnia, guilt, and the isolation of living under constant surveillance. “You can
