Yet critics note that this top-down implementation often sidelines critical discussion, reducing the tool to a mechanical output rather than a cognitive aid. In sub-Saharan Africa, stem-and-leaf has found niche applications in community-based health monitoring. In Kenya, local NGOs use simplified versions to track maternal health outcomes in regions with limited digital infrastructure, pairing visual outputs with oral storytelling traditions to bridge literacy gaps. This hybrid approach—combining visual clarity with narrative context—offers a model for culturally responsive data use.
