Finland’s holistic approach balances rigor with well-being, embedding math in interdisciplinary projects that connect to environmental science, economics, and civic life. Singapore’s hybrid model—rigorous yet adaptive—uses AI diagnostics to personalize learning while preserving teacher expertise. In contrast, the U.S. relies on standardized testing regimes that pit schools against each other, often exacerbating inequities. High-stakes exams like SAT and ACT emphasize speed and memorization, discouraging deep learning. A 2022 Brookings study found that 70% of teachers spend over half their time “teaching to the test,” narrowing curricula and increasing student disengagement.
