This geographic diversification enriches the test's pedagogical value, exposing participants to varied legal environments, cultural narratives, and forms of resistance.

Industry Impact: Shaping the Next Generation of Investigators

Others caution against over-reliance on standardized metrics in a field defined by nuance and unpredictability. This network, supported by open-source tools and cross-border mentorship, aspires to become a bulwark against disinformation and authoritarian narrative control.
