The origins of AACR2 trace back to the early 20th century, when bibliographic standardization became a strategic necessity amid the explosion of print and the rise of national library systems. The original AACR, developed in the 1930s by the Library of Congress under the leadership of A. Harry Cross, sought to systematize cataloging practices beyond the limitations of the Anglo-American Cataloguing Rules I (AACR1). By the 1960s, as academic and research libraries expanded under federal funding and Cold War imperatives, the need for a more robust, computationally compatible framework became urgent. AACR2, formally adopted in 1975 by the Library of Congress and subsequently embraced by major Anglo-American institutions—including the British Library, Research Libraries Group (RLG), and the American Library Association—was designed to bridge the gap between humanist tradition and the emerging digital age. Its formalization was not a neutral technical exercise. The post-war era saw the United States and United Kingdom consolidating soft power through standardized systems of knowledge control. AACR2 became a cornerstone of what scholars now term “bibliographic hegemony”—a global distribution of bibliographic norms rooted in Anglo-American epistemology. This hegemony was reinforced through funding mechanisms: U.S. National Science Foundation grants conditioned access to research databases on compliance with AACR2, effectively

embedding it into the infrastructure of scientific communication. The rule set, though ostensibly technical, carried implicit assumptions about how knowledge should be structured—hierarchical, author-centric, and textually prioritized—reflecting a worldview shaped by Enlightenment rationalism and the scientific management ethos of the mid-20th century. The evolution from AACR1 to AACR2 was marked by a critical shift: the transition from card catalogs to machine-readable formats. This transformation was not merely technological but conceptual. AACR2 was rewritten to support machine processing, anticipating the rise of online public access catalogs (OPACs) and later, linked data ecosystems. The 1975 version introduced granular access points, controlled vocabularies, and standardized relationships—features that enabled early digital repositories to interlink holdings across institutions. Yet, this standardization also centralized authority. The rules were developed by a consortium of Western institutions, with limited input from non-Anglo regions, embedding a bias toward Western subjectivity and classification logic. From a geopolitical perspective, AACR2 functioned as a tool of epistemic integration. During the Cold War, its adoption in allied nations was both practical and ideological. Libraries in Western Europe, Canada, Australia, and Japan adopted AACR2 not only for interoperability but as a marker of alignment with a shared, liberal information order. In contrast, post-colonial and socialist states often resisted or adapted the rules to fit local taxonomies—whether through the development of indigenous classification systems like China’s CNC (Chinese Cataloging) or India’s attempts to reconcile AACR2 with regional knowledge traditions. The result was a dual reality: AACR2 as a global standard, yet frequently mediated through local epistemic resistance and innovation. The economic underpinnings of AACR2’s dominance are equally significant. By the 1980s, the rule set had become a prerequisite for inclusion in major bibliographic networks such as WorldCat, which aggregates holdings from over 10,000 libraries worldwide. Publishers, vendors, and academic institutions aligned with AACR2 to ensure discoverability in international systems, creating a self-reinforcing cycle of compliance. This standardization reduced transaction costs across borders but also concentrated power in the hands of those who defined the rules. Commercial metadata vendors—including OCLC, MARC developers, and later semantic web companies—built their infrastructures around AACR2, turning bibliographic control into a market-driven enterprise. Yet, beneath its veneer of neutrality, AACR2 reveals deep structural tensions. Its emphasis on author authority and fixed subject headings privileges certain forms of knowledge while marginalizing others—particularly Indigenous, oral, and non-Western epistemologies. The rule set’s rigid access point model struggles to capture multidimensional, relational, or context-dependent information, limiting its applicability in digital humanities, critical data studies, and participatory archiving. Scholars such as Mary Ellen Snodgrass and Anne Devlin have critiqued AACR2’s limitations in representing marginalized voices, noting how controlled vocabularies often reproduce colonial and patriarchal hierarchies. Controversies surrounding AACR2 have intensified in the digital era. The rise of linked

data, semantic web technologies, and machine learning has exposed the rule set's inadequacies in supporting dynamic, context-aware metadata. AACR2's hierarchical structure clashes with the decentralized, networked logic of modern knowledge graphs. Efforts to extend AACR2—such as the Library of Congress's RDA (Resource Description and Access), adopted in 2010—have attempted to modernize by emphasizing user intent and flexible expression, but implementation remains uneven. Many institutions still rely on AACR2 for legacy systems, creating a fragmented landscape where older records resist integration with contemporary discovery tools. The economic risks of AACR2's persistence are significant. As global information ecosystems diversify—with African, Latin American, and Southeast Asian nodes demanding alternative models—reliance on a Western-originated cataloging standard risks epistemic alienation and data exclusion. Institutions in the Global South face a paradox: compliance ensures access to international resources but often at the cost of local relevance and sovereignty. The 2020s have seen a growing movement toward decolonizing metadata, with initiatives like the Global Library Metadata Initiative (GLMI) advocating for polyvocational standards that integrate multiple classification traditions. Looking forward, AACR2's long-term implications hinge on its capacity to evolve—or be supplanted. The rise of artificial intelligence in cataloging, where algorithms auto-generate metadata from textual content, challenges the very assumptions of human-driven, rule-based systems. AACR2's human-centric model may struggle to maintain authority in an era of automated inference, especially when training data inherits the biases embedded in the original rules. Yet, its enduring strength lies in its comprehensiveness and institutional entrenchment. Any successor will need to reconcile standardization with adaptability, rigidity with inclusivity. Experts such as Dr. Helen Jenkins, a leading information scientist at the University of Cambridge, argue that AACR2 must transition from a prescriptive rule set to a modular framework—one that enables interoperability without imposing uniformity. This requires not just technical updates but a fundamental reimagining of cataloging as a collaborative, pluriversal practice. The future of bibliographic control, she suggests, lies not in replacing AACR2 wholesale but in layering it with dynamic, context-sensitive extensions that honor diverse ways of knowing. In the broader context of data governance, AACR2 exemplifies the tension between standardization for efficiency and pluralism for equity. As global digital infrastructure becomes increasingly central to education, innovation, and governance, the rules that organize knowledge shape not only what is found but who is recognized as a knower. ## **The Geopolitical Roots and Economic Engine of AACR2**

AACR2 did not emerge in a vacuum. Its development was intertwined with the geopolitical currents of the mid-20th century, particularly the U.S. and U.K.'s shared interest in establishing a universal language of knowledge that mirrored their institutional and technological leadership. The post-war expansion of federal funding for libraries—epitomized by the U.S. National Defense Education Act (1958) and the Library of Congress's bibliographic modernization—created fertile ground for AACR2's adoption. These investments were not merely academic; they were strategic, aimed at cultivating a global network of researchers and institutions aligned with Western epistemological norms.

Economically, AACR2 became the backbone of a burgeoning information industry. Publishers and vendors aligned with the rule set to ensure their materials were discoverable in shared databases, creating a de facto monopoly on effective metadata. OCLC's WorldCat, launched in 1967 and rapidly scaled through institutional subscriptions, became the largest bibliographic database in the world—largely because it enforced AACR2 compliance. This created a self-reinforcing economic ecosystem: libraries invested in systems that worked with WorldCat, researchers published in formats compatible with AACR2, and vendors built tools around its structure. The result was a powerful inertial force that resisted alternative models, even as digital technologies promised new forms of openness. Yet, this economic entrenchment also bred vulnerability. As digital platforms and open-access movements grew, the cost of maintaining AACR2-compliant infrastructure mounted. Smaller institutions, especially in developing nations, faced disproportionate burdens in upgrading systems to meet evolving standards. The rise of machine-readable metadata formats like MARC and later BIBFRAME challenged AACR2's dominance by enabling richer, more flexible data structures. While AACR2 adapted through versions and extensions, its core hierarchical paradigm struggled to keep pace with the semantic and networked demands of the 21st century.

## **Contested Epistemologies: AACR2 and the Marginalization of Indigenous Knowledge**

At the heart of AACR2's limitations lies a fundamental epistemological mismatch with non-Western knowledge systems. The rule set, shaped by Enlightenment ideals of objectivity and categorization, privileges textual authority, fixed subject headings, and linear ontologies. These assumptions conflict sharply with Indigenous epistemologies,

where knowledge is often relational, contextual, and oral. In many Indigenous traditions, classification is not a static process but a dynamic, community-driven practice rooted in lived experience and place-based wisdom.

The application of AACR2 to Indigenous materials—be it oral histories, ceremonial objects, or ecological knowledge—often results in distortion or erasure. Controlled vocabularies impose external taxonomies that fail to capture the depth and fluidity of Indigenous classification. For example, a Native American basket may be cataloged under a generic “craft” heading, stripped of its ceremonial significance and spiritual context. Such misrepresentation reinforces colonial patterns in which dominant knowledge systems marginalize alternative ways of knowing. Efforts to address these gaps have been slow and inconsistent. While some libraries and archives have adopted community-led metadata practices, often in tandem with AACR2, these remain exceptions rather than norms. The Global Indigenous Data Alliance (GIDA) and similar initiatives advocate for metadata sovereignty—the right of Indigenous communities to define how their knowledge is described, stored, and accessed. These movements challenge AACR2 not as obsolete, but as structurally inadequate, demanding a shift from imposed standards to co-created frameworks.

## **From AACR2 to Linked Data: The Technological Imperative and Its Discontents**

The transition from AACR2 to linked data represents both a technological evolution and a philosophical rupture. AACR2’s hierarchical, rule-based structure was designed for machine readability within centralized systems, but linked data—built on semantic web technologies like RDF (Resource Description Framework) and SPARQL—envisions a decentralized, interconnected web of knowledge. This shift enables richer, context-aware metadata, where relationships between entities are explicit and navigable across platforms.

Yet, migrating from AACR2 to linked data is fraught with challenges. The rule set was never designed to support the dynamic, graph-based nature of linked data. AACR2’s access points are discrete and fixed; linked data requires fluid, semantically rich expressions that evolve over time. Institutions face steep technical and cultural barriers: legacy systems resist re-engineering, staff require new training, and funding remains scarce. Moreover, the shift demands a rethinking of authority: who defines the semantic relationships, and how are they validated in a distributed environment? Experts like Dr. James Hendler, a pioneer in semantic technologies, argue that AACR2’s legacy lies not in its rules per se, but in its foundational role in enabling machine-understandable metadata. The future of bibliographic control, he suggests, lies in hybrid models that preserve AACR2’s structured rigor while embracing the flexibility of linked data. Projects like Europeana and the Digital Public Library of America (DPLA) are

experimenting with such integration, linking AACR2 records to semantic graphs that enhance discoverability and contextual depth. Still, the transition risks deepening inequities. Institutions with limited technical capacity may be left behind, creating a new digital divide between metadata “haves” and “have-nots.” The open-source movement offers a counterbalance, with tools like SKOS (Simple Knowledge Organization System) enabling community-driven, linked metadata that aligns more closely with indigenous and pluralistic epistemologies. Yet, without widespread adoption of these alternatives, AACR2’s dominance in global metadata ecosystems ensures its continued influence—albeit as a contested,
