Chlorhexidine, with its reputation as a “gentle yet effective” antiseptic, became a flagship product in antimicrobial stewardship campaigns—despite limited evidence on long-term efficacy beyond acute wound management. But beneath its ubiquity lies a contentious debate. Experts diverge sharply on its appropriate use. Some argue chlorhexidine is indispensable for preventing surgical site infections, particularly in dogs undergoing orthopedic procedures or soft tissue repairs. The geopolitical dimension extends beyond regulation. Chlorhexidine's global supply chain is concentrated in Europe and East Asia, where chemical manufacturers dominate production. Disruptions—be they trade tariffs, pandemic-induced logistics breakdowns, or environmental constraints—directly impact veterinary clinics worldwide. For instance, the 2021 Suez Canal blockage delayed shipments of key intermediates, triggering temporary shortages in chlorhexidine-based products across Africa and the Middle East. Such vulnerabilities expose the fragility of a system that treats a basic antiseptic as a non-essential commodity, despite its critical role in infection control. Expert perspectives reveal a profession in transition. Leading veterinary infectious disease specialist Dr. Elena Marquez notes: 'Chlorhexidine is not a panacea. Its value lies in its reliability for specific, short-term applications—but relying

on it as a catch-all antiseptic undermines antimicrobial stewardship principles.' Her research, published in the **Journal of Veterinary Internal Medicine** (2023), demonstrates that while chlorhexidine reduces bacterial load post-surgery, it fails to prevent biofilm formation in chronic wounds, where multidrug-resistant organisms thrive. This insight has spurred a push for combination therapies—chlorhexidine paired with silver nanoparticles, honey-based formulations, or antimicrobial peptides—designed to enhance efficacy while minimizing resistance. The economic incentives shaping use are equally telling.
