Germany’s “Nursing Resilience Pact” combines public training pipelines with regulated mobility, ensuring that foreign staff meet national standards and transition smoothly into local systems. In contrast, Southeast Asia’s model—dominated by private staffing—prioritizes rapid deployment but struggles with quality control and nurse retention.
