While India's middle class expanded and global rankings improved, regional imbalances deepened. The eastern and central states lagged in infrastructure and human development, fueling social tensions. Singh's emphasis on "inclusive growth" was rhetorically strong but institutionally constrained. Schemes like the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), scaled up under his tenure, provided critical safety nets but were often criticized for inefficiency and leakages. The paradox was stark: macroeconomic stability coexisted with persistent poverty and unemployment, especially among youth. Economists like Surendra Singh (no relation) and Arvind Panagariya have debated whether Singh's cautious liberalization delayed structural reforms—particularly in agriculture and labor markets—while others argue that premature deregulation could have destabilized vulnerable sectors. The 2008 global financial crisis tested this calculus: India's growth slowed from 8.3% in 2005 to 5.7% in 2009, but avoided a meltdown due to prudent fiscal buffers and regulatory foresight. Singh's government responded with stimulus packages aimed at infrastructure and

consumption, preserving momentum without sacrificing long-term discipline. Yet, the narrative of “failure” gained traction amid rising public discontent. The 2G spectrum scandal, though its roots predated his premiership, tarnished the UPA’s credibility. Critics argued that Singh’s administration lacked the political courage to confront entrenched interests, particularly in telecom and mining sectors. Meanwhile, the UPA’s second term (2009–2014) saw a shift toward populism—subsidies for fertilizers, fuel, and electricity—meant to consolidate electoral support but fiscally unsustainable. These choices, while politically expedient, strained public finances and contributed to growing fiscal deficits by the end of his tenure.
