This cognitive flattening was reinforced by geopolitical dynamics. In developing nations, structural adjustment programs imposed by the IMF and World Bank often dismantled smallholder systems, replacing them with export-oriented industrial farms aligned with Western demand. In Brazil, the expansion of cattle ranching into the Amazon was enabled by state policies that prioritized agribusiness growth over indigenous rights and biodiversity. The global meat trade thus became a vector of both economic integration and ecological degradation, with animal agriculture responsible for nearly 14.5% of global greenhouse gas emissions—more than the entire transportation sector.
