advising Indian port authorities. “Training must evolve with the work—not just mirror outdated risks.” This tension between tradition and transformation is mirrored in the tools of training. While simulation-based learning—using VR to replicate forklift collisions or electrocution risks—is gaining traction, adoption remains uneven. High-cost, high-accuracy systems are accessible primarily to global logistics giants. Gaps, Barriers, and the Shadow of Underreporting

Despite progress, systemic vulnerabilities remain. OSHA’s 2022 audit of 500 U.S. distribution centers found that 63% had documented dock safety violations, with the most frequent being unguarded edges, blocked emergency exits, and inadequate fall protection. But these figures represent only the tip of the iceberg. Underreporting is endemic: workers fear retaliation, especially in non-unionized environments; employers underreport incidents to avoid penalties; and regulators in many nations lack the capacity to enforce standards. The International Trade Union Confederation estimates that 80% of loading dock injuries go unreported globally. Controversies also persist around liability and accountability. In the 2019 collapse of a major Amazon fulfillment center dock in Texas—where a worker was killed after being pinned by an automated pallet handler—lawsuits revealed conflicting narratives: Amazon cited “obsolete training protocols,” while union investigators pointed to rushed implementation and understaffed safety teams. The case underscored a broader issue: training, when disconnected from real-time operational feedback and accountability mechanisms, risks becoming symbolic rather than substantive. A 2023 ILO report documented 140+ dock-related fatalities in Nigeria's logistics sector over the past decade—numbers widely believed to be undercounted.
