This oral tradition drew from African griot traditions, Caribbean sound system culture, and urban blues, but adapted to a new context: the digital-age fragmentation of community. Graffiti, breakdancing, and DJing formed a triad of cultural resistance, each

reinforcing the others. The MC's role evolved from entertainer to storyteller, embedding personal and communal narratives within rhythmic cadence. As scholar Barri Platkin notes, "The MC was not just a performer; they were a cultural engineer, stitching together identity through rhythm and rhyme." The economic context was critical. The economic evolution of rap is a narrative of democratization and commodification. In its early years, the business was grassroots: independent labels like Sugar Hill Records and Def Jam operated on scraps of capital, relying on turntables, cassette recorders, and word-of-mouth.
