Ethicists, meanwhile, have engaged deeply with her

framing of pharmacological justice. Dr. Kwame Osei, a bioethicist at the University of Cape Town, argues that Shanbhag's work advances a 'rights-based pharmacology'—one that centers marginalized populations in drug development. 'Her insistence on inclusive clinical trials and equitable pricing isn't just policy—it's moral imperative,' Osei notes. Yet, he cautions: 'Systemic change requires more than critique; it demands institutional reform and sustained political will.' Within academic circles, her interdisciplinary methodology has inspired a new generation of scholars. Dr. Elena Petrova, a pharmacoepidemiologist at Harvard, praises her 'narrative rigor': 'She doesn't just analyze data—she contextualizes it, showing how pharmacology is shaped by culture, politics, and economics. That's the future of the field.' Petrova highlights Shanbhag's role in bridging gaps between bench science and public health policy, a synthesis often absent in traditional pharmacology curricula.
