Yet, even in democracies, the erosion of press freedom undermines this role. Hungary’s gradual dismantling of media independence under Orbán, where critical outlets face regulatory pressure and state-aligned media dominate, illustrates how political power seeks to control narrative. In the U.S., recent legislative proposals to restrict source protection and expand surveillance powers threaten the confidentiality essential to investigative work. Globally, the UN Special Rapporteur on Freedom of Expression reports a worrying trend: over 300 journalists imprisoned in 2023, many for doing their job. This geopolitical tension underscores a deeper reality: truth is not neutral. It is contested, weaponized, and protected. When journalists expose war crimes, tax evasion, or environmental destruction, they challenge entrenched interests—corporations, governments, criminal networks. The

consequences are not abstract: the 2019 murder of Brazilian journalist Dom Phillips, investigating indigenous land rights, was not an isolated crime but a symptom of systemic impunity. His death, like countless others, silences voices that others depend on to speak truth.
