Controversies persist over the commercialization of LoA metrics. In the U.S., private rehabilitation networks have been criticized for inflating Level 4 and 5 placements to justify higher reimbursement, a practice known as 'upcoding.' In the U.S., Medicare and Medicaid use LoA data to determine coverage and reimbursement, with Level 4 and 5 interventions commanding premium payments.
