Osei's vision aligns with growing calls across the continent for decolonized assessment models that honor linguistic pluralism without sacrificing communicative competence. Pedagogical experts emphasize that the scheme's rigidity can distort teaching practices. In many Weac-administered schools, "teaching to the test" dominates English instruction, with teachers focusing narrowly on grammatical accuracy, essay structure, and vocabulary drills. This approach, while boosting short-term scores, often undermines deeper language acquisition—critical thinking,

creative expression, and intercultural communication. As Dr. Ngozi Eze, a curriculum specialist in Nigeria, observes: 'When exams reward formulaic writing over narrative richness, we train students to produce correctness, not competence.' The tension between standardization and adaptability is not merely academic. It reflects a broader struggle over what counts as legitimate knowledge in postcolonial education systems. Finally, regional collaboration among West African education bodies—through shared rubrics, cross-border teacher networks, and joint research—could strengthen the scheme’s legitimacy and responsiveness.
