In practice, veterinarians frequently recommend feeding small, frequent meals (4–6 times daily) to accommodate reduced appetite and improve digestion. Monitoring feed intake and body condition score weekly allows timely adjustments—particularly in advanced disease, where appetite may fluctuate. Supplementation with branched-chain amino acids (BCAAs) has shown promise in preserving lean mass and mitigating encephalopathy. A 2020 randomized controlled trial in dogs with chronic hepatitis found that BCAA-enriched diets (1.2 g/kg/day leucine, isoleucine, valine) significantly improved whole-body nitrogen retention and reduced serum ammonia compared to standard diets, with no adverse effects. However, BCAA dosing must be individualized—excess leucine may paradoxically stimulate ammonia production via branched-chain ketoacid dehydrogenase activation—underscoring the need for veterinary oversight. Omega-3 fatty acid supplementation, particularly EPA and DHA from fish oil, has been associated with reduced hepatic inflammation and fibrosis progression. Some diets rely on low-quality, plant-based proteins with incomplete amino acid profiles, increasing reliance on urea cycle pathways and fueling ammonia production. Others omit critical micronutrients or include pro-oxidant ingredients that exacerbate oxidative stress. Veterinarians must critically evaluate ingredient sourcing, PDCAAS scores, and supplementation practices—opting for brands with transparent labeling and evidence-based formulations. A critical error is inadequate hydration management. Hepatic dysfunction often disrupts fluid balance, increasing risk of dehydration and renal compromise. Owners frequently underestimate the importance of consistent water access or mistreat vomiting episodes without electrolyte replacement. Encouraging high-moisture diets (canned, moistened kibble) and administering subcutaneous fluids under veterinary guidance is vital to maintain perfusion and support toxin clearance. Overreliance on supplements without clinical indication is another frequent misstep. While B-vitamins, zinc, and antioxidants can aid recovery, indiscriminate use risks toxicity—especially in renal-compromised patients.
