Initially, assessments focused narrowly on vehicle operation and traffic law compliance, reflecting a minimalist regulatory ethos. The 2010s marked a turning point. With the rise of app-based platforms and growing public concern over ride-hailing safety, the UK government mandated standardized testing across all private hire operators. Wolverhampton adapted by integrating vehicle inspection protocols, behavioral ethics, and emergency response drills. The 2016 rollout of digital assessment platforms allowed real-time data tracking, enabling regulators to refine criteria based on performance analytics. Today, the test mirrors broader shifts toward data-driven governance, embedding metrics on driving patterns, passenger interaction, and environmental compliance into its framework.

## **Geopolitical and Economic Context: Fragmentation, Pressure, and the Gig Economy**
