As noted by Dr. Meera Desai, a political economist at Savitribai Phule Pune University, “Nemade's career mirrors the rise of a class that does not fully belong to the old elite

nor the pure market-driven innovator. He operates in the liminal space where policy, power, and production converge—a space that defines contemporary Indian industrialism.” Yet this liminality also breeds risk. The very networks that enable rapid growth—caste alliances, political patronage, informal labor arrangements—can become liabilities during policy shifts or governance crises. The 2019 Maharashtra Industrial Policy reforms, aimed at increasing transparency and environmental accountability, placed new constraints on firms reliant on flexible labor and land acquisition. Nemade’s ventures, while resilient, faced recalibration: renegotiating contracts, enhancing compliance, and diversifying supply chains to mitigate regulatory exposure. Globally, the Kosala model invites comparison with similar industrial transitions in Southeast Asia—Vietnam’s textile boom, Bangladesh’s garment sector, and Indonesia’s automotive push. In each case, rapid industrialization has been propelled by a mix of state support, foreign investment, and localized social adaptation. However, unlike these economies, Maharashtra’s transition occurred within a federal system with fragmented regulation, entrenched caste politics, and a media landscape that amplifies dissent.
