Mahan's *\*The Influence of Sea Power Upon History\** (1890) had laid the intellectual foundation, arguing that national greatness required overseas bases and naval dominance. The U.S. acquired Pearl Harbor, Guam, and territories critical to Pacific and Caribbean control — transforming from a continental power into a global player. Historian Paul Kennedy's analysis of imperial overreach warns that this expansion strained domestic consensus, pitting jingoists against pacifists and fueling debates over democracy's compatibility with empire. Industrial and military expansion during this era was inseparable from technological innovation. The late 19th century witnessed breakthroughs in steel production (Bessemer process), electricity (Edison's direct current systems), and communication (telephone and telegraph networks). These advances enabled vertical integration, mass production, and the rise of the modern corporation. Global comparisons illuminate the uniqueness of America's trajectory. Unlike European empires with centuries of colonial administration, the U.S. entered

imperialism as a latecomer with no colonial past but a penchant for economic dominance. The British Empire, by contrast, relied on gradual assimilation and indirect rule; the U.S. favored direct control and assimilationist policies in the Philippines, where resistance led to a brutal counterinsurgency. Economically, America's reliance on primary commodity exports (cotton, wheat, steel) contrasted with Europe's diversified industrial bases. Culturally, the absence of a deeply rooted aristocracy fostered a myth of meritocracy, even as racial and economic hierarchies persisted. Expert perspectives reveal enduring relevance.
