For instance, recent iterations have incorporated questions on telemedicine liability, AI in diagnostics, genetic editing ethics, and the legal responsibilities tied to social determinants of health—all domains where Oklahoma's regulatory framework is either pioneering or lagging. At the core of the jurisprudence exam lies a tension: the board seeks to assess not merely rote knowledge, but the capacity to navigate ambiguity. A physician must interpret state statutes like Oklahoma Statutes Title 21, Chapter 112—particularly Sections 112.11 (Scope of Practice) and 112.13 (Professional Conduct)—through the lens of contemporary clinical practice. The expectation is that responses demonstrate awareness of both literal legal mandates and the spirit of physician autonomy, balanced against patient welfare. This legal framing is deeply embedded in Oklahoma’s geopolitical and economic context. As a state historically anchored in agriculture, energy, and resource extraction, Oklahoma’s healthcare system has long grappled with rural-urban disparities, workforce shortages, and limited infrastructure. These structural realities directly influence the board’s regulatory posture.
