His argument was not that truth-telling is futile, but that the cost has been redefined in an environment where reputation is currency, and reputation can be destroyed in hours. He cited internal sources—journalists, editors, and digital security experts—who described how coordinated campaigns now exploit emotional vulnerability: doxxing, deepfake amplification, and narrative hijacking designed to fracture focus and legitimacy. The piece resonated globally because it reflected a growing dissonance: the public demands accountability, yet rarely prepares for the human toll.
