Her early work, recognized with multiple international awards, exposed how disinformation became a weapon of war, where facts were not just distorted, but weaponized to erode public trust and legitimize violence. By the mid-2020s, Voss observed a shift: disinformation had migrated beyond battlefields into the quiet corridors of global institutions, corporate boardrooms, and diplomatic negotiations. The public, saturated with competing claims and algorithmic echo chambers, no longer distinguished between misinformation and strategic obfuscation. Voss asked: **How do we measure the erosion of truth when the lie itself has become a form of control?** This question crystallized into a new mission: not merely to expose falsehoods, but to map the **architecture of deception**—the systems, incentives, and power structures that enable it. What emerged was **Lie with Me: English Edition**, a project conceived as a longitudinal, multi-scalar investigation into the global culture of strategic untruths.
