In the 18th century, Euler, Lagrange, and Laplace pioneered analytical methods, deriving differential equations that described orbital perturbations. Lagrange’s five great theorems (1772) identified invariant points in rotating reference frames—cornerstones for understanding stable configurations like the Lagrangian points. Laplace’s work on perturbations laid the foundation for modeling how perturbations from the Moon, Sun, and planetary oblateness alter orbits over time. These were not abstract exercises; they enabled precise predictions of comet trajectories, such as Halley’s Comet’s return, confirming Newtonian mechanics at cosmic scales. The 20th century transformed astrodynamics from theoretical pursuit to operational necessity. The launch of Sputnik in 1957 marked not just a political milestone but a technical turning point. Solving these analytically is generally impossible beyond the two-body problem. Instead, astrodynamics employs numerical integration techniques: Runge-Kutta methods, Adams-Bashforth-Moulton for stability, and symplectic integrators that conserve energy and angular momentum over long timescales. The choice of numerical scheme affects mission longevity—especially critical for geostationary satellites or interplanetary probes enduring decades of flight.
