The global market for forensic bioinformatics tools is projected to exceed \$4.5 billion by 2030, driven by rising crime rates, expanded DNA collection policies, and public demand for technological transparency. However, this growth benefits a narrow set of vendors with proprietary software licenses, creating monopolistic tendencies. Open-source initiatives like the Open Forensics Initiative and the Global DNA Standards Consortium attempt to counterbalance this by promoting interoperable, community-audited platforms. Yet, their reach remains limited without sustained public funding and political will.

Beyond commercial and national interests, the virtual lab

On the other, it concentrates power in algorithmic gatekeepers, where proprietary models and data silos limit competition and transparency.
