This descent into extreme dietary manipulation is rooted in history, shaped by modern industrial military logistics, and now amplified by a globalized wellness economy that commodifies survival. The diet’s rise cannot be understood through caloric charts alone; it requires unpacking the interplay of physiological limits, institutional culture, and the broader implications of compressing human adaptation under pressure. The origins of intensive military nutrition regimes trace back to the early 20th century, during World War I and II, when armed forces first recognized that combat effectiveness hinged not only on weaponry but on soldier conditioning. During these periods, malnutrition and deficiency diseases—scurvy, beriberi, pellagra—were silent adversaries, often costing more lives than battlefield wounds. The U.S. Army’s 1943 Field Manual 21-20, **Nutrition for the Soldier**, marked a turning point, advocating for balanced macronutrient ratios and vitamin supplementation to sustain endurance. Yet, the focus remained on sufficiency: preventing deficit, not optimizing rapid transformation.
