Later, the advent of agriculture approximately 10,000 years ago imposed new mechanical demands: repetitive tilling, carrying water and grain, and prolonged kneeling—all reinforcing musculoskeletal density and resilience. Yet this adaptation came with trade-offs: population-level declines in muscle mass and strength, as sedentary labor reduced mechanical loading, a phenomenon now accelerating in industrialized societies. From a biomechanical perspective, skeletal muscles are not passive tissues but dynamic, energy-intensive organs. Comprising myofibrils packed with actin and myosin filaments, they generate force through the sliding filament theory, fueled by aerobic and anaerobic metabolism. This high metabolic demand makes muscles the body's largest consumers of

ATP—accounting for up to 40% of basal metabolic rate. The system's reliance on oxygen, glucose, and fatty acids ties muscular function directly to nutritional status, cardiovascular health, and systemic inflammation. Countries with strong agricultural or industrial bases historically prioritized physical conditioning. Soviet-era military training programs, for instance, integrated hyper-efficient musculoskeletal conditioning to prepare soldiers for arduous field operations, recognizing that operational effectiveness hinges on physical endurance. Today, nations facing demographic aging—Japan, Italy, South Korea—are reevaluating muscular maintenance as a public health imperative. Japan's "Silver Athlete" initiative, launched in 2020, promotes age-targeted resistance programs to counteract sarcopenia, projecting a 15% reduction in age-related disability by 2035 if scaled nationally. In contrast, conflict zones and regions afflicted by food insecurity witness accelerated muscular degradation. In Yemen, where 80% of the population lacks adequate protein intake, pediatric muscle atrophy rates exceed 22%, impairing both growth and future economic potential. Similarly, in Ukraine, ongoing military conscription has revealed widespread muscle wasting among conscripts, with 43% exhibiting reduced grip strength post-deployment—a condition linked to prolonged stress, malnutrition, and disrupted recovery. Meanwhile, mechanical loading devices—vibration platforms, exoskeletons—are increasingly deployed in manufacturing and logistics to mitigate worker strain, signaling a shift toward proactive musculoskeletal engineering. Biotechnology is now redefining muscle repair and enhancement. CRISPR-based gene editing targets myostatin, a negative regulator of muscle growth, with experimental therapies showing potential to increase lean mass by 20–30% in preclinical models. While promising, such advances raise ethical and regulatory dilemmas: therapeutic use in athletes versus enhancement, equity in access, and long-term epigenetic effects. The World Anti-Doping Agency has already classified myostatin inhibition as a Class S prohibited method, yet

enforcement lags behind innovation. Clinically, the muscular system lies at the nexus of chronic disease. Sarcopenia, the age-related loss of muscle mass, affects 10% of adults over 60 and up to 50% by 90, significantly increasing fall risk and frailty. Yet sarcopenia is not inevitable—it is modifiable through physical activity, protein intake, and management of inflammation. Post-surgical, post-illness, or post-traumatic muscle atrophy can delay convalescence by months, increasing dependency and healthcare burden. Advanced therapies—hyperbaric oxygen, neuromuscular electrical stimulation, and personalized protein regimens—are improving outcomes, but access remains limited. In low-resource settings, the absence of physical therapy infrastructure exacerbates disability, perpetuating cycles of poverty and reduced productivity. Environmental factors further strain the muscular system. A 2024 investigation by *The Lancet* exposed clinics offering gene therapy treatments with no long-term

safety data, targeting individuals under 25—a demographic particularly vulnerable to irreversible side effects. Ethically, the line between therapeutic use and enhancement blurs. Should athletes with genetic predispositions to muscle loss receive therapeutic intervention? Can society ethically permit enhancement that widens physical inequality? These questions challenge regulatory frameworks ill-equipped for rapid biotech evolution.
