Economically, China's digital health sector has boomed, with firms like Tencent and Huawei providing the backend infrastructure, turning health data into a strategic asset. In Europe, the General Data Protection Regulation (GDPR) of 2018 imposed a high bar for consent, data minimization, and transparency. This slowed the adoption of broad health card systems, though pilot programs persisted. The UK's NHS Test and Trace, launched in 2020, used a decentralized digital card model with encrypted entry, but faced criticism for inequitable access and technical failures. Meanwhile, Estonia's long-standing e-Health system—dating to the 1990s—demonstrated a successful model: a national digital ID linked to comprehensive health records, enabling citizens to access test results, prescriptions, and consultations via a single app. Estonia's system, built on blockchain principles, became a benchmark for secure, interoperable health data. In Kenya, the National Health Insurance Fund (NHIF) integrated mobile-based testing into its digital wallet system, allowing rural patients to log

COVID-19 tests via SMS, though literacy barriers limited uptake. Economic incentives further shaped the landscape. Test manufacturers like Abbott and Roche vertically integrated health card ecosystems, offering devices paired with cloud-based analytics platforms. This created vendor lock-in, particularly in low-resource settings where procurement decisions were driven by donor funding rather than systemic compatibility. In India, the Ayushman Bharat Health Account—launched in 2021—partners with private labs (like Apollo and Fortis) to link test results to a national digital identity, but interoperability with state-level systems remains a challenge. Market consolidation has intensified. By 2023, the top five health tech firms—Roche, Siemens, IBM Watson Health, Tempus, and Abbott—controlled over 60% of the global digital health card and diagnostic testing market. As Dr. Tedros Adhanom Ghebreyesus, Director-General of WHO, noted in 2024: 'We are building a world where health data can prevent disease—but only if it serves people, not profit.'
