In the Middle East, political volatility constrains open research, though think tanks in the Gulf have cautiously adopted behavioral gravity to model youth engagement and economic diversification. This could establish a new intellectual sovereignty for behavioral science, resisting technocratic overreach. Fourth, education and professional training must evolve. Universities are beginning to embed gravitational thinking into curricula, emphasizing interdisciplinary fluency, ethical reflexivity, and participatory methodology.
